Another successful year has passed. It is all thanks to our many members who step up, volunteer and make the club a welcoming place for all levels of play. We continue as always to receive many favourable comments about friendliness and the social benefits of belonging to our club. This cannot be underestimated as with the growth of the club many new members come to venues daily so always reach out to help them with all of the procedures and questions if they have any!

President's Message

SAPC continued to grow in 2023 and we ended the year with 963 Members.

We continue to offer a variety of organised play both at Alpine and at our indoor venues along with mentoring and beginner lessons for anyone who wants to learn pickleball. Over the years we have changed to adapt to new technology systems, new financial systems, add new venues and accommodate an ever growing number of members. With the reciprocal agreement with the city of St. Albert we are fortunate to have 12 indoor sessions at the schools on a weekly basis during the fall and winter season. However at the heart of the club are the Board and volunteers who work tirelessly on a daily basis for the betterment of the club.

Martin Luther King junior said "Volunteers do not necessarily have the time; they have just the heart!" Thank you to our wonderful volunteers; your support of the club allows us to continue to fulfil our mission and serve our pickleball community!

Key Accomplishments

- We remain the second largest pickleball club in Alberta in terms of memberships.
- In 2023, SAPC surpassed our records from the previous year in terms of indoor and outdoor play sessions for members, number of members served, tournament numbers and attendance, club revenue and expenses, rating clinics, lessons and mentoring, goods sales, and more.
- The City of St Albert welcomes our input, and recognises the Club's professional approach in planning for its future.

As well, work was initiated or completed in the following areas:

- adopting and implementing a new accounting system.
- researching adoption of a performance-based player rating system. (DUPR)
- Negotiations with the City of St Albert regarding an operating agreement for Alpine Courts was ended in December (See facilities Task committee report)
- Ongoing dialogue with the City of St. Albert administration regarding its plans for indoor and outdoor facilities continues.
- One Possession Academy venue was added to our list of venues. Northpointe no longer rents out their gym due to their own programming. Parking issues and extra costs meant that we dropped Level One as a venue!

We are very fortunate to have a venue manager (Eileen) who makes it her priority, year round and day in-day out, to seek out and pursue all potential play venues.

Facilities Task Force

- This Task Force has, as its prime objective, the development of a plan to have expanded
 or additional outdoor and indoor pickleball play facilities available in St. Albert. All
 avenues are open for consideration, including rentals, lease, construction and
 development, pursuit of grants, partnership with Active Communities and the City of St.
 Albert (COSA), and more.
- As was recommended and approved in prior years (and in accordance with Facility Strategy papers published on the SAPC website), SAPC continues to build a capital reserve to fund an SAPC share of future facilities.
- Members of this task force have met with COSA to promote, explore and learn about opportunities to have more pickleball facilities built in St. Albert.
- The task force met with COSA Parks and Recreation representatives at various times in the last year to negotiate a possible operation agreement with the City of St. Albert for Alpine courts. It became clear that the risks and costs vs the benefits of such an agreement were more than SAPC can accept at this point in time.
- Thanks to Eileen McClean, James Porter, Douwe Spriensma, and Ray Keroack for their work on this task force.

Ratings

In February 2023 a newly formed Rating Committee comprised of Karen Cabot, Jeanine Au, James Porter, Ray Keroack, Roger Hutlet, Art Au, and Eileen McClean was tasked to investigate and implement DUPR as a club rating system option for members.

The rating coordinators, Karen Cabot and Jeanine Au, had their first indoor session in April at Red Willow with nine members. Another 17 indoor sessions from April to June followed at 2 venues – Red Willow and Bertha Kennedy School. One session was played at J. Demko but was not well received.

We were fortunate to have BK school until the end of June, with 3 courts it provided the best option to get more members rated (13 per session). At first, it was very difficult to keep up with the rating demand from members – many rating sessions would fill up within 15 minutes with another 10 -15 members on the waitlist.

Fortunately, Ray Keroack organised a summer Wednesday night 3.5 DUPR shootout which helped with ratings for this level. The rating coordinators could then concentrate their DUPR rating sessions for unrated members and offer play sessions for 3.0s trying to improve their DUPR rating. Some emails were received from this group asking for more DUPR play sessions, like the 3.5s had, as they also wanted to play with their peer group/friends without having to go to other venues to play.

Warm weather allowed rating sessions to continue at Alpine with 7 sessions offered from July to October 4th - four of which were 3.0 play sessions.

October to December offered 1 rating session each month, due to limited court space, with an 'am' and 'pm' session at BK. It must be noted that each time an indoor DUPR session was offered, whether it be rating or play, a group from the calendar was bumped from their regular play schedule. In nine months, 31 DUPR sessions were organised and 160+ members received a rating, with the majority being a 2.5, 3.0, 3.5 and 1-4.0.

Even then, some members did one session with SAPC and played at other DUPR events/venues to complete their 20+ games required. At the November Rating Committee meeting, it was decided that the Rating Coordinators would only schedule indoor DUPR rating sessions for unrated members once a month due to limited court time. Also, it was unanimously decided at this meeting to automatically upgrade member's DUPR rating to a consolidated Club rating following their 20 DUPR games. Previously members had to request an upgrade.

DUPR has recently improved their algorithms to include "points matter" again - think we are all happy to see this back again!

Volunteers

- SAPC has a healthy volunteer list for various aspects, see the Website team lists for a comprehensive list of committees and volunteers. We could not operate without these volunteers and are so grateful for their service.
- To recognize and appreciate their efforts we held two Volunteer Appreciation Events early summer and fall . Thank you again volunteers!

Finance Team

- The Finance team of Laura Spencer handles all our accounting, including budgeting, financial reporting, forecasting, sticker/venue tracking, bank and GIC management, and service pricing. Our board members and auditor are all provided with monthly income statements, balance sheet, forecasts and a Treasurer's report. We're glad some people like working with all those numbers and spreadsheets.
- As approved by our Board, the Finance team implemented QuickBooks Online to be used for all the financial/accounting information for the club.

• A review was done of all financial controls to ensure the financial assets of the club are safe. Some minor improvements were made.

Information Technology Team

- This team includes Tamas Virag, Ray Keroack, James Porter (Pickleball Brackets and Pickleball Desk), Douwe Spriensma, Dragan Radovic and Laura Spencer (financial apps). This team is responsible for implementing and supporting the various information technologies used by SAPC, including Wild Apricot; Pickleball Brackets; Affinipay/First Data; Stripe; Google admin (accounts, email, and drive); Zoom; Pickleball Canada National System (PCNS); QuickBooks Online and DUPR. Some of the work carried out this year includes:
 - Setting up and administering our club on DUPR, including maintaining club membership on DUPR.
 - Commencing a project (headed by club historian Reta Thomson) to capture and post some additional historically noteworthy and valuable club photos, stories, and other artefacts.
 - Training and supporting directors, managers, reserved play coordinators, calendar coordinators, training coordinators, venue manager and coordinators, and rating coordinators in the use of our Wild Apricot website, membership management, event management and email system.
 - Working with these other volunteers (many of whom are identified via the roles above) who are becoming increasingly responsible for developing and maintaining the content of our website pages.
 - Training of tournament volunteers to operate Pickleball Brackets and Pickleball Desk.

Auditor

• Lawrence Taylor, our experienced auditor, was re-elected at our last AGM and, as directed by the membership, has conducted a financial and records review. The review report will be presented to the membership at the March 2024 AGM.

Goods Sales Team

 Thanks to Laura Spencer for taking over from Marion Spriensma for the orders for sticker cards and she faithfully fulfils the orders. Our sales of sticker cards have been as follows in recent years. This involves a lot of organising (thank you Laura) all so our members can keep playing indoors. Members now have the option of picking up their stickers locally in a specially made mailbox with a pickleball on top!! (Thank you, Gary Spencer for creating this mailbox!)

Development

Mentoring and training

- Mentoring sessions, both indoor at Bertha Kennedy School and outdoor at Alpine Courts were organised.
- A beginner lesson is held every Sunday at Red Willow, coordinated by Nicole Currie.
- This year 59 beginner sessions were held teaching 348 participants.
- 19 mentoring sessions were held with 281 participants.
- 8 beginner sessions were held for the school kids, approx 20 kids per session for a total of 160

Refereeing

 We hosted a referee clinic in June and our club now has 16 certified referees. We will be looking to see if there is demand to host another clinic this year.

Membership and Volunteers

 As a newly appointed role, to fulfil the vacant position left by Carol Mah, Art Au stepped into this position and continued to keep our membership administration working, updating ratings in the database, tracking PCO and PA memberships and taking care of many other details. Youth membership was also added to this role.

Communications Team

- Peter Sha took on the role of Social Medial Coordinator in December, 2022 and has continued in this role until present day many thanks Peter!!
- In his role as Social Media Coordinator, Peter has accomplished the following:

- Finalised set up of the WhatsApp groups for all ratings levels, captains, etc.;
 these WhatsApp groups facilitate targeted communicated amongst Club members
- Sent out WhatsApp invitations to new members
- Added and deleted members from WhatsApp groups based upon their joining or leaving the Club
- Added/Deleted members from WhatsApp groups based upon player rating changes
- Approved/Declined requests to join our Club Facebook group (only active members are permitted to join)
- Occasionally posted content to the Facebook Group page as requested/approved by the Club

Newsletters and Emails

• The Communications Director kept the membership informed on all topics believed to be of interest to Club members. During 2023, for example, 15 Newsletters were published. Many thanks to our Club Directors, volunteers and other members who contributed topics and content to the articles published in these many Newsletters.

Health Coordinator and Team

• The team kept our first aid supplies for each venue stocked. Jeanine Au was the key person responsible for this work along with Art Au who also helped. An AED was purchased early in the year but it took several months to revive the AED. It was put in place late September at Alpine. The club was lucky enough to receive a grant and the monies used \$2200 will be reimbursed to the club!

Tournament Coordinator and Team

We hosted the following tournaments in 2023:

- In June we had a club tournament with 212 players which at the time was our largest tournament to date and also larger than many sanctioned tournaments held by other clubs.
- July 15-17th we hosted our second Pickleball Canada Sanctioned tournament with . The tournament was a huge success and we received many compliments from players from other clubs.
- We also ran another club tournament in Sept with 135 players that was very well received by our members.

- Special thank you to all the members who helped out during these tournaments to make them a success.
- We will be running all three tournaments again in 2024 and they will be put on Pickleball brackets in the next few weeks.
- We ran a 4.0+ league play this year which was team-based play with 6 teams. This was the first type of team-format play in Alberta and was very well received. We received many compliments on the league format and are hoping to continue that this season.

Junior Play

- We now have a few Juniors joining regular play.
- Due to lack of court availability, there were no scheduled junior play sessions

Nominating Committee

• The Nominating Committee, chaired by Kevin McClean, with members Cassy Campbell and Brenda Regehr has served the membership well, providing nominees for the various board positions and the other positions that need to be elected at the AGM.

 developing plans to keep up with the demand for pickleball facilities.
- With this in mind, and with the membership's continued support, the club will continue to build its capital reserve to be used for future facilities. This reserve will help secure a down-payment, qualification for matching grants, capital improvements to a leased facility, or funds for some other facility development.
- In the meantime, we will pursue new short term facility options and make optimum use of our current facilities.

In closing, to all of you, each and every volunteer and member, it is a pleasure and an honour to share a court with you! We are so blessed at SAPC to have a wonderful Board who works behind the scenes in so many capacities for the betterment of the club! Each day there are venues being managed, play organised for so many levels; our wonderful volunteers working daily for the club!!
